COST Action(s): A personal journey

- COST Actions: different from the "usual" research grants. Do not finance research per se, emphasis is on networking
- very good platform for exange of ideas and creation of strong partnerships around a common theme
- bottom up you can create your own network and program
- very adaptive you can change and add various tools and ways to achieve goals during the course of the Action
- COST Actions are a growing organism
- great for personal growth and scientific career
- extremely important for young career researchers
- bridging the gap between science and non-scientific sector
- benefits to economy and other interested parties

CA 19141: Integrating Neandertal legacy: From Past to Present (iNEAL)

Step 1: defining a common theme for the Action that:

- we are familiar with
- can be of interest to wider audience (both scientific and non-scientific)
- Is of pan-European (not just national or local) interest

Our reasoning:

- Neandertals are a pan-European phenomenon. Their heritage is not linked to national interests only.
- they do not need introduction (everyone familiar with the term)
- novel interest in Neandertals and new sets of data (e.g. genomic research, which can benefit us directly (e.g. personal medicine)
- benefits to non-scientific sector (e.g. tourism, local communities, small business etc.)

Therefore: <u>A good common theme and a good starting point</u>

CA 19141: Integrating Neandertal legacy: From Past to Present (iNEAL)

Step 2: defining the questions/goals/issues etc.

- a great deal of information (cultural, biological data etc) is available on Neandertals
- yet there are many biases and gaps (and not just for scientific reasons)

This is related (but not limited) to:

- availability of technical and monetary resources for scientific research,
- missing expertises (or people trained in specific types of analysis),
- lack of communication between different disciplines,
- lack of communication with foreign scientists (especially in the past e.g. "behind the iron curtain"),
- different development of disciplines in different countries,
- language barriers (especially underrepresentation of "non-western" scholars, or in local languages not cited in "western" publications),
- different legal rules and regulations related to study of cultural/biological heritage,
- and so on.

Recognizing problems and potentials for Neandertal research, we wanted to adress the major issues outlined above in order to:

- overcome biases created by language, geography, traditions of different disciplines...
- create a pan-European, inter and multidisciplinary nettwork of scholars interested in Neandertal heritage
- create an open and growing database(s) and sharing platforms related to Neandertal heritage
- use the Neandertal heritage as a fertile ground and starting point for development/growth of various trades (e.g tourism, SME, etc.)
- create a solid basis for the development of "The Neandertal Trail" European cultural route



Step 3: coping with issues (or how to do what we set out to do):

- Working groups, dedicated to various aspects of Neandertal heritage (WG1: the fossil data; WG 2: the cultural data; WG3: genetic data)
- Evaluation of Neandertal hertiage and inclusion into the present (making Neandertals relevant for everyone WG4)
- Regular <u>MC and WG meetings</u> (in person and on line)
- <u>Training schools (e.g. 4 TS per GP times 4 = 16 TS, with between 15-20 trainees over 200 people will aquire new skill sets) also targeting specific biases (e.g. economic/lack of expertises etc).</u>
- <u>STSM's</u> focusing on early career scientists (we had 6 during the 1st GP, we will have 12 calls from the 2nd GP). Valuable experience that will help the Action goals and make a huge advantage in the young researcher's career
- <u>Dissemination grants</u> for attendance of various professional meetings (presentations), publications and so on
- <u>Expanding the network</u> (at the start, our Action at the time of approval: 12 countries and 28 proposers involved. At the end of the 1st GP, we had 28 countries and 69 people involved (MC/substitute MC's and WG members)
- testifying to the high importance of the COST Actions: not only number of top scholars (e.g. there are several grantees of ERC project in our Action – one of them is a three time grantee of ERC project grants), but involvement and interest from young researchers and nonscientific sector

Problems and opportunities:

- one of major problems related to COVID -19 and travel restrictions
- good thing: COST is staying on top of things and allows changes and adaptations to be made
- as long as the goals are being met, it is easy to change and adapt the process
- re-evaluating the Action and targeting the issues (not as strict as research grants)
- rules and regulations are clear and available (Vademecum)
- the COST personnel very helpful and is working for and with you
