Provjere temeljene na samoprocjeni mogu pokrenuti temeljitu sigurnosnu provjeru.

Platforma za upravljanje znanjem namijenjena je mapiranju, kategorizaciji i stimulaciji suradnje između stručnjaka za kibernetičku sigurnost kao potpore digitalnoj strategiji EU.

Glavni ciljevi platforme:

- bolje koordinirati europska istraživanja i razvoj u području kibernetičkoj sigurnosti
- pomoći u prepoznavanju s kim surađivati na budućim projektima
